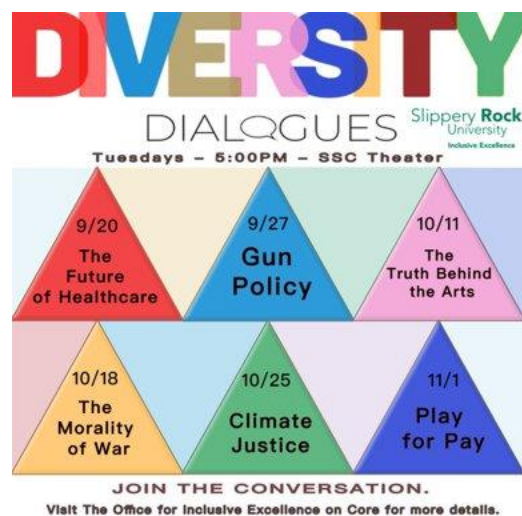

### Commission Reports:

**Senator McLafferty** – This past week I attend the GEISO commission. GEISO is the president’s commission on gender identity & expression and sexual orientation. With Dr. Jones, we tried to develop an encompassing vision and mission statement. They are looking for more students to sit on the commission. They talked about making a collaborating event with all of the commissions for a celebration and the commissions can highlight what they have done for the year.

**VP Gish** – As Hannah mentioned earlier in her report, PCRED is looking for another SGA-appointed representative. PCRED is the president’s commission on race and ethnic diversity. If anyone is interested come see me, President D’Egidio, or VP Hood. I have sent emails to co-chairs, but I have yet to hear back.

**VP Shaffer** – She’s on my committee and she’s always very active. Whenever she is given a task, she always gets it done, and she does it well.

### Open Forum:

**Senator Moore** – We do or do not have office units due next week?

**Speaker Austin** – Just do your best and if you’re short, you’re short. Just submit them.

**Senator Moore** – College of Health Professions senators, don’t forget that headshots are tomorrow at Patterson.

**Chloe Janice (Club Softball)** – Originally, we asked for \$10,000 and you asked us to cut it, and you cut it down to \$5,455. You asked us to take out food, hotels, and drop our 5 drivers to 3 drivers. So you dropped us down to \$3,544. With that money, our fee that is due soon is \$1,375. That takes us down to \$2,169. With 3 drivers to the tournaments, all of that is \$1,612. We don't have enough money with dropping it down to 3 drivers. We have 15 girls. If we did 3 cars, that would be 5 people per car with equipment. Most of these are overnights, so it would include double bags. On top of that, the max you capped us at is okay, but it's not fair that you took out money for all of these other fees. Last year we had to pay for everything out of our pocket. We request that we get that \$5,455.

**VP Jones** – I talked about currently looking at replacements for the NextBus app. Committee brought it to my attention, and Wendy and I have been in contact with a new company. They agreed to send us a tracker to test out on one of the buses. Wendy and I agreed that it would be worth testing out. I will keep you guys updated on that if we can test it during fall break. I had a meeting with Provost Zieg, so thank you for all of those questions. I will type up a report and send it out to you all by the end of the week.

**Senator Resnick** – I have a question. If they are unable to meet the fees, will they be unable to participate in the tournament?

**VP Husnick** – When we were looking this over, we made sure to cover the fees. We cut travel.

**Senator Blanchard** – I'm going to agree with finance. I think they did well. I am a part of a club that got travel fees cut as well. If we agree, I think other clubs will come and ask for more.
