Old Business:

Motion #1: I move to approve the proposed amendments to the SRSGA Constitution and Bylaws as read.

Senator McLaughlin – It was in the email, and I think they did a very good job.

Par. Thrasher – There were 21 proposed amendments to the constitution and bylaws. Most of them were clerical-type things, adding an athlete senator position, and changing VP of Diversity & Inclusion to Diversity, Equity, Inclusion. and Belonging.

Par. Thrasher – We did hold a public forum for these motions. No one from the student body showed up. I was supposed to report on the last one, but I forgot.

President D'Egidio – Senator Warren, can you give us a rundown?

Senator Warren – This is holding people accountable. We have a legislative and executive branch. The judiciary branch would be an outside source to hold people accountable. We want this part to be a long-lasting addition to our constitution.

Senator Froehlich – The first time we looked at this was last spring. We've been working on this for a long time. I think we should push it through.

Senator Warren — I move to amend the Judiciary Branch as read to say Article N to say Article VI, Article Z to Article VIII, Section II Subsection B Subsubsection E Subsubsubsection II to change the period at the end to a comma and add "the investigation process will take place within a week of the next fall or spring semester."

VP Hood – Are the articles supposed to be roman numerals or numerical values?

Senator Warren – Roman numerals.

Par. Thrasher – I move to table the amendments to the judiciary branch at this time.
