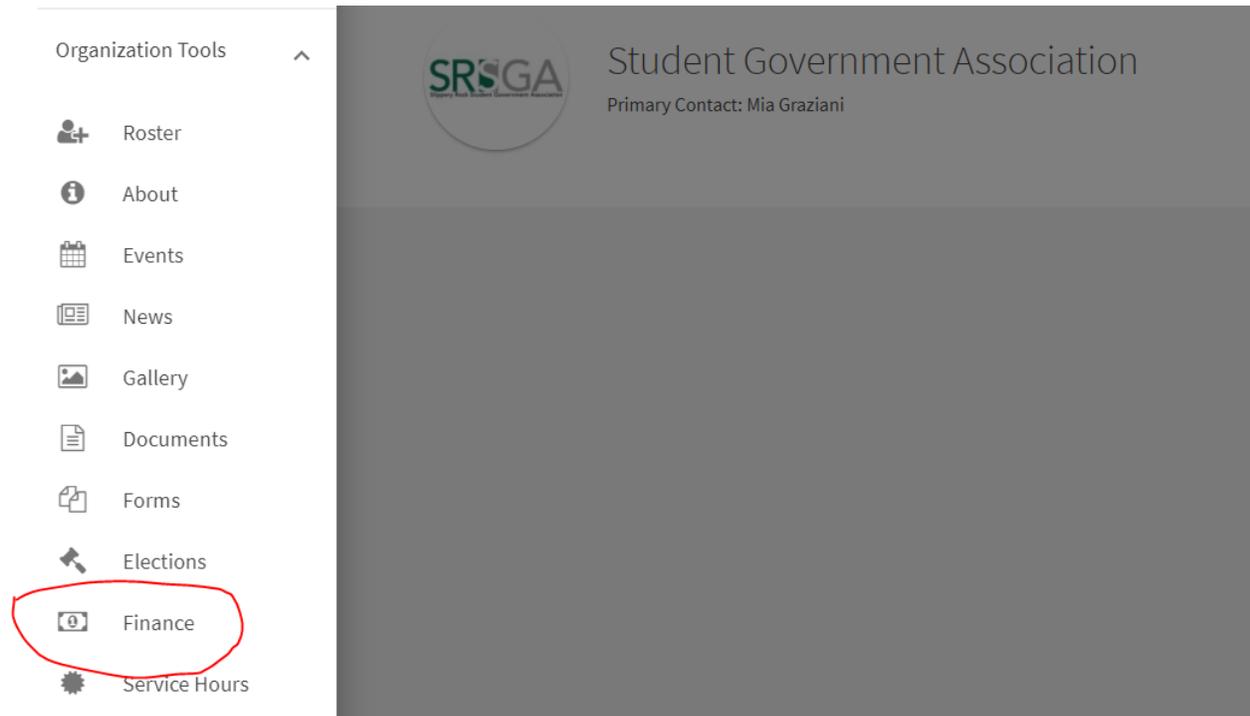
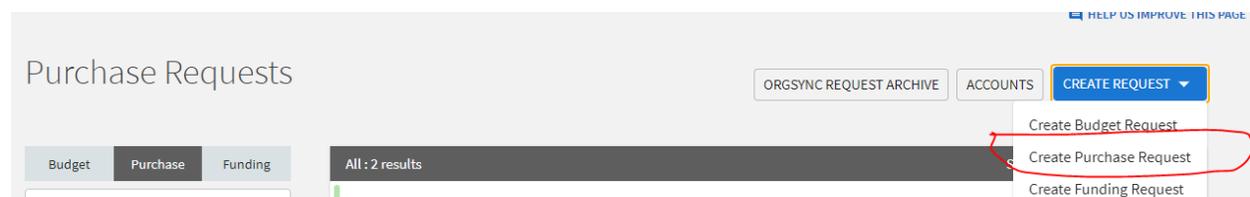


To access purchase requests, switch to the *Manage* view of your organization, open up the organization tool drawer (3 horizontal lines), and select *Finance*. This option will only appear for you if you hold a position in your organization with organization-level access to Finance.



A purchase request (aka “payment request”) is a record of money that is being spent from your organization’s SGA approved budget account. To submit a purchase request, once you have accessed your organization finance page, click the blue *Create Request* drop-down followed by "Create Purchase Request."



To create your purchase request, please follow the instructions in the “Additional Information” field at the bottom of the page. Please note, you cannot submit a request unless you follow the instructions and all required fields are populated.

## Additional Information

To begin, click "Populate from Budget" and select the approved budget and budget line for your request. If a budget line does not exist, you will need to request a line item transfer before you can submit further. Your approved budget line will populate the subject field, description field, and total amount allocated to that budget line. You can edit the description field to be specific to the expense item you are requesting. Please be as detailed as possible. You will also need to change the "amount" to match what you are requesting. Please note, you cannot request more than the approved line. Next, select a category (line item) from the drop down that matches the expense. Finally, choose your account-this will be your organization's budget account. The payee information should be filled out completely. If you are seeking a reimbursement or payment to an individual, please include first and last name. If paying a company, please include the full company name in the "first name" field along with complete address. Finally, you must upload all receipts, invoices, or other supporting documentation before you can submit your request. Also, please indicate if you are picking up your check or if you would like our office to mail it for you.

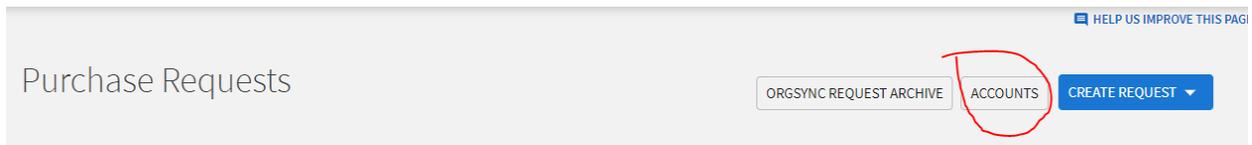
